ASUR Announces Total Passenger Traffic for

September 2016 Up 12.1% Year over Year

**Mexico City, October 4, 2016 - Grupo Aeroportuario del Sureste, S.A.B. de C.V. (NYSE: ASR; BMV: ASUR)**

(ASUR), the first privatized airport group in Mexico and operator of Cancun Airport and eight other airports in southeast Mexico, as well as a 50% JV partner in Aerostar Airport Holdings, LLC, operator of the Luis Muñoz Marín International Airport in San Juan, today announced that total passenger traffic for September 2016 increased by 12.1% when compared to September 2015.

This announcement reflects comparisons between September 1 through September 30, 2016 and 2015. Transit and general aviation passengers are excluded.
