- (1) On November 13, 2006, NextWave Wireless Inc. became the successor to NextWave Wireless LLC pursuant to a merger. The merger resulted in NextWave Wireless Inc. becoming the parent holding company of NextWave Wireless LLC, but did not alter the proportionate interests of security holders.
 - (2) The option vests in forty-eight equal monthly installments beginning March 1, 2006 but was fully exercisable on the date of grant as to all 90,592 shares. Any unvested portion of the option will be exercisable for restricted shares subject to the same vesting schedule.
 - (3) Pursuant to the agreement governing these options, the options converted from options to purchase shares of stock of Cygnus Communications, Inc. (a subsidiary of the issuer) to options to purchase shares of common stock of the issuer in connection with the merger described in note (1).
