As previously announced Turkcell signed an agreement for a US\$3 billion unsecured syndicated financing through a committed facility on February 26, 2007.

While Turkcell continues to evaluate international investment opportunities, Company does not foresee any immediate financing need for a particular project within the time frame which the committed facility is made available. Therefore, Company has decided to cancel the facility at this time and potentially to reinstate its efforts for a financing arrangement in the future, in case of need.
