AK Steel Holding Corporation (“AK Steel”) has prepared presentation materials (the “Investor Presentation”) that management intends to use from time to time on and after June 9, 2016 in presentations regarding AK Steel’s business, operations, performance and other matters. Item 8.01 Other Events.

AK Steel noted that its top financial priorities include the reduction of indebtedness over time by approximately \$700 million in principal amount and addressing its debt maturity profile, including through a variety of potential capital markets actions from time to time. These actions, which are subject to market conditions, may include, without limitation, (i) the refinancing of its 8.75% Senior Secured Notes due 2018; (ii) the repurchase of a portion of its senior unsecured notes in the open market on an unsolicited basis, by tender offer, through privately negotiated transactions or otherwise; (iii) the equitization or refinancing of its 5.00% Exchangeable Notes due 2019; and, (iv) positioning the company to opportunistically issue additional common stock.
