On October 15, 2018, The Cincinnati Insurance Company (Applicant), a subsidiary of Cincinnati Financial Corporation, entered into a Reimbursement Agreement (Agreement) with the Bank of Nova Scotia (Bank). The Agreement is for a new unsecured letter of credit facility that will allow the Applicant to secure letters of credit totaling up to \$25,000,000 to support the collateral obligations of its assumed reinsurance division. The Agreement requires Applicant to reimburse Bank on demand any amounts drawn under a letter of credit issued by Bank pursuant to the terms of the Agreement. The Agreement includes other financial covenants that require Applicant to reimburse Bank for commissions, taxes and interest. The Agreement will replace an existing letter of credit facility entered into on April 25, 2016, with U.S. Bank. The U.S. Bank facility will be terminated as soon as all regulatory approvals have been received.
