DTE Energy Company (“DTE Energy”) will meet with investors at the EEI Financial Conference in Phoenix, Arizona November 6-8, 2016. Chairman of the Board and Chief Executive Officer Gerard M. Anderson will provide a business update to the EEI Financial Conference at approximately 11:15 MST November 8, 2016. A copy of the slide presentation from the meetings and the business update presentation is furnished as Exhibit 99.1 to this report and will be available on DTE Energy's website, www.dteenergy.com on November 4, 2016. The business update presentation will be available via live webcast and archived for future viewing through a link on DTE Energy's website, www.dteenergy.com. In the meetings and the presentation, DTE Energy reaffirms its 2016 operating earnings guidance range of \$5.09-\$5.35 per share. DTE Energy also announced its early outlook for 2017 operating earnings guidance range of \$5.15-\$5.46 per share.

In its business presentation and this filing, DTE Energy discusses 2016 and 2017 operating earnings guidance. It is likely that certain items that impact the company's 2016 and 2017 reported results will be excluded from operating results. Reconciliations to the comparable 2016 and 2017 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
