Press release issued February 28, 2007 in which the Registrant announced that it has filed on SEDAR the updated Technical Report on its 100% owned Courageous Lake project (see news release dated January 9, 2007). The updated Technical Report confirms the previously announced new resource estimate. The Report also compares contained ounces of gold in conceptual pits that were generated at various gold price levels using the operating parameters from the Preliminary Assessment Study completed in 2005 (see news release dated September 21, 2005). The new analysis suggests that the projected mine life at Courageous Lake may be significantly greater than the 8.5 year mine life estimated in the 2005 Preliminary Assessment.
