This Amendment No. 4 amends and supplements the Tender Offer Statement and Rule 13e-3 Transaction Statement filed under cover of Schedule TO with the Securities and Exchange Commission on June 10, 2003 by ICN Pharmaceuticals, Inc., a Delaware corporation ( ICN ), relating to the Offer (as defined below) to purchase all outstanding shares of common stock, par value \$.01 per share, of Ribapharm Inc., a Delaware corporation (the Company ), not owned by ICN or its subsidiaries, at a purchase price of \$5.60 per Share, net to the seller in cash, upon the terms and subject to the conditions set forth in the Offer to Purchase, dated June 10, 2003, and the related Letter of Transmittal (which, as amended or supplemented from time to time, together constitute the Offer ).

**Item 11. *Additional Information.***

(a)(5) On June 25, 2003, ICN commenced an action in the Court of Chancery in the State of Delaware for declaratory and injunctive relief against the Company and its board of directors seeking to invalidate the Company s stockholder rights plan adopted by the Company s board of directors on June 20, 2003 and to obtain a temporary restraining order to bar the distribution of exercisable rights on July 11, 2003 under the Company s stockholder rights plan.
