The engagement of Rothstein, Kass & Company, P.C. is expected to commence as of the beginning of the Company's 2002 fiscal year.

Registrant has solicited and received from Arthur Andersen LLP, its former accountants a statement from them agreeing with the statements made by Registrant in response to Item 304(a) of Regulation S-K which is annexed as Exhibit 3 hereto and hereby incorporated herein by reference.
