**Item 8.01 Other Events**

On September 18, 2008 Otter Tail Corporation (the Company ) entered into a Purchase Agreement (the Purchase Agreement ), with Merrill Lynch, Pierce, Fenner & Smith Incorporated, Robert W. Baird & Co. Incorporated, J.P. Morgan Securities Inc., Banc of America Securities LLC, Wells Fargo Securities, LLC and KeyBanc Capital Markets Inc. (collectively, the Underwriters ), relating to the issuance and sale of 4,500,000 of the Company s common shares, \$5 par value per share (the Initial Securities ). The Company also granted the Underwriters a 30-day option to purchase up to an additional 675,000 of its common shares for the purpose of covering overallocments, if any (the Option Securities and together with the Initial Securities, the Securities ). On September 22, 2008, the Underwriters exercised in full their option to purchase the Option Securities. The sale of the Securities, which is subject to customary closing conditions, is expected to close on September 24, 2008.

The Securities were offered at a public offering price of \$30.00 per share, with net proceeds before expenses to the Company of \$28.9125 per share. The net proceeds to the Company from the offering, after payment of estimated offering expenses, of approximately \$149,222,188 (including the net proceeds from the exercise in full of the Underwriters overallocation option), will be used to finance Otter Tail Power Company s construction of the Ashtabula Wind Center in Barnes County, North Dakota, the expansion of the wind tower manufacturing facilities of DMI Industries, Inc. in Tulsa, Oklahoma, and West Fargo, North Dakota, and to fund working capital needs of the Company s other businesses.

The Securities will be issued pursuant to the prospectus supplement filed September 19, 2008, in connection with the Registration Statement on Form S-3, Registration No. 333-116206, as amended (the Registration Statement ), filed by the Company with the Securities and Exchange Commission.
