Paul E. Singer ("Singer"), Elliott Capital Advisors, L.P., a Delaware limited partnership ("Capital Advisors"), which is controlled by Singer, and Elliott Special GP, LLC, a Delaware limited liability company ("Special GP"), which is controlled by Singer, are the general partners of Elliott. Hambleton, Inc. ("Hambleton") is the general partner of Elliott International. International Advisors is the investment manager for Elliott International. International Advisors expressly disclaims equitable ownership of and pecuniary interest in any Common Stock.

Elliott Associates, Elliott International and International Advisors' aggregate beneficial ownership of 7,000,102 shares of Common Stock constitutes 8.4% of all the outstanding shares of Common Stock.
