(a) Amount Beneficially Owned:

As of the date of this filing, each Reporting Person may be deemed to be the beneficial owner of 818,100 shares of Common Stock owned by Millenco, L.L.C., a Delaware limited liability company ("Millenco") (formerly known as Millenco, L.P.) which shares are a constituent part of the Company's units ("Units") of which Millenco holds 818,100. Each Unit consists of (a) one share of Common Stock, and (b) one warrant ("Warrant"). Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$6.00. Each Warrant will become exercisable on the later of the Company's completion of a business combination and June 7, 2008, and will expire on June 7, 2011, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination.

Millennium Management, L.L.C., a Delaware limited liability company ("Millennium Management"), is the manager of Millenco, and consequently may be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the shares owned by Millenco.

Note: Integrated Holding Group, L.P., a Delaware limited partnership ("Integrated Holding Group"), is a non-managing member of Millenco. As a non-managing member, Integrated Holding Group has no investment or voting control over Millenco or its securities positions.

(b) Percent of Class:

7.6% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 10,781,250 shares of Common Stock outstanding as of June 13, 2007 following the Company's completion of its initial public offering and the underwriters' exercise of their over-allotment option, as reported by the Company on a press release, dated June 13, 2007.
