Of the 3,375,830 shares beneficially held by the Reporting Person, 2894,305 shares represent securities or warrants or other rights to purchase securities held by certain discretionary or non-discretionary managed accounts and private investment funds managed by Ault Glazer Asset Management LLC, for which the Reporting Person serves as chief investment officer, and 481,525 shares represent securities or warrants or other rights to purchase securities held by the Reporting Person individually. Except for the shares held by the Reporting Person individually, the Reporting Person disclaims beneficial ownership of these securities, and this report shall not be deemed an admission that the Reporting Person is the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(1) The transaction above was pursuant to satisfaction of certain debt obligations owed by certain accounts managed by the Reporting Person, to a third party, by issuing equity securities, specifically PST common stock, owned by such accounts managed by the Reporting Person. The Reporting Person disclaims beneficial ownership of the securities disposed of in this transaction and this report shall not be deemed an admission that the Reporting Person was the beneficial owner of such securities for purposes of Section 16 or for any other purpose.

(3) As of January 5, 2007, the Reporting Person resigned as Chief Executive Officer of PST and on January 9, 2007, the Reporting Person resigned as Chairman of the Board of Directors of PST and from the position as a member of PST's Board of Directors.
