### DEREGISTRATION OF UNSOLD SECURITIES

On November 22, 1999, Synvista Therapeutics, Inc., formerly known as Alteon Inc. (the "Company"), filed a registration statement on Form S-8 (File No. 333-91437) (the "Registration Statement").
