(b) On August 13, 2007, the Board of Directors (the "Board") of Harsco Corporation ("Harsco") today announced the retirement of Derek C. Hathaway as Chairman and Chief Executive Officer of Harsco, fully effective after the April 2008 Annual Meeting of Stockholders.

Salvatore D. Fazzolari, who currently serves as President, Chief Financial Officer and Treasurer, will succeed Mr. Hathaway as Chief Executive Officer effective January 1, 2008. Additionally, and in accordance with Harsco's current Governance model, it is expected that Mr. Fazzolari will be elected Chairman upon Mr. Hathaway's retirement from the Board in April 2008. At this time, there has been no new, or modifications to existing employment agreements with Messrs. Hathaway and Fazzolari as a result of this announcement.
