On August 5, 2015, Harsco Corporation issued a Press Release announcing its earnings for the second quarter ended June 30, 2015. Among other things, the Press Release reports:

- Diluted earnings per share from continuing operations of \$0.08 in the second quarter of 2015 compared to diluted loss per share from continuing operations of \$0.17 in the second quarter of 2014;
- Operating income in the Harsco Metals & Minerals Segment of \$18.6 million in the second quarter of 2015 compared to operating loss of \$7.3 million in the second quarter of 2014; and
- Net cash provided by operating activities of \$34.7 million and \$47.8 million in the second quarter of 2015 and 2014, respectively.
