Item 3.01 Notice of Delisting or Failure to Satisfy a Continued Listing Rule or Standard; Transfer of Listing

On January 26, 2012, the NASDAQ Stock Market announced that it will delist the common stock of eDiets.com, Inc. (the Company). The Company s common stock was suspended on December 2, 2011, and has not traded on NASDAQ since that time. NASDAQ announced that it intends to file a Form 25 with the Securities and Exchange Commission to complete the delisting. The delisting is expected to become effective ten days after the Form 25 is filed.

The Company s common stock is currently traded on the OTCBB market under the symbol DIET. The NASDAQ delisting will not affect the eligibility of the Company s common stock to trade on the OTCBB market.
