Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On June 11, 2015, the Board of Directors ( Board ) of National Fuel Gas Company (the Company ) elected Joseph N. Jagers to serve as a director of the Company, to hold office until the Company s next Annual Meeting of Stockholders. Mr. Jagers is Chairman, Chief Executive Officer and President of Jagged Peak Energy LLC, a Denver-based private energy company involved in the acquisition, development and exploration of oil and gas assets in select North American basins. Mr. Jagers has been named to the Board s Audit Committee.

The Company will compensate Mr. Jagers in the same manner it compensates its other non-employee directors, as described at page 13 of the Company s proxy statement filed January 23, 2015, and as supplemented by this Current Report. Effective April 1, 2015, the annual retainer paid to non-employee directors is \$54,800 plus 2,400 shares of the Company s common stock. In addition, fees paid to non-employee directors for each meeting of the Board in excess of six meetings per year will be \$1,800 (no fee will be paid for the first six Board meetings), and fees paid to non-employee directors for each committee meeting will be \$1,800. The Lead Independent Director and the chairman of each of the Audit, Compensation and Nominating/Corporate Governance committees will receive an additional annual retainer of \$15,000. In addition, like the Company s other directors, Mr. Jagers has received an indemnification agreement, the terms of which are described in the Company s Form 8-K filed September 18, 2006.
