Voting Agreement Amendment No. 3 amends the Amended and Restated Voting Agreement, dated as of January 19, 2010 (as previously amended, the Original Voting Agreement and, as further amended by Voting Agreement Amendment No. 3, the Voting Agreement), among the parties as described in Items 2, 3 and 4 of this Amendment No. 10.

Voting Agreement Amendment No. 3 resulted in the joinder as parties to the Voting Agreement of Mahira Nabulsi Abu-Ghazaleh and Saif Ahmad Abu-Ghazaleh. Voting Agreement Amendment No. 3 also amended the Original Voting Agreement to (i) expressly permit the joinder of parties in the future through a separate joinder document rather than through a formal amendment to the Voting Agreement and (ii) update Exhibit A to the Original Voting Agreement to reflect current beneficial ownership information as of the date of Voting Agreement No. 3.
