 The Series G Shares are to be redeemed pursuant to Section 3(a)(i) of the Company s Articles Supplementary for the Series G Mandatory Redeemable Preferred Shares, filed with the State Department of Assessments and Taxation of the State of Maryland on September 10, 2013.
- (4) The principal amount or number of shares and the basis upon which the securities to be redeemed are to be selected: The Company will redeem 2,000,000 of the outstanding Series G Shares, representing an aggregate liquidation preference amount of \$50,000,000.00, at a total redemption price of \$50,012,777.78 and a redemption price per share of \$25.0063889. The redemption price per share is equal to \$25.00, plus accumulated but unpaid dividends of \$0.0063889, calculated using the current rate of 4.60% accrued (whether or not earned or declared by the Company, but excluding interest thereon) to, but not including, the redemption date. The redemption price per share does not include the monthly dividend of \$0.095834 per share to be paid by the Company on September 1, 2016 and on October 3, 2016.
