Corillian Corporation was acquired by CheckFree Corporation on May 15, 2007, resulting in a change of control, pursuant to which each share of Corillian Common Stock was exchanged for the right to receive \$5.15 in cash. At the effective time of the acquisition of (1) Corillian Corporation by CheckFree Corporation, the vesting of all outstanding stock options accelerated, each outstanding stock option was converted into the right to receive the excess, if any, of \$5.15 over the exercise price per share of such stock option, and each outstanding stock option was then terminated upon the change of control.
