- (2) Adjusted to reflect 580 shares of the Issuer's Class B Common Stock representing dividend equivalents paid on deferred but vested RSUs that were previously reported as Restricted Share Units on Table II and are now reported on Table I.

The RSUs are paid out six (or more) months after the Director's retirement from the Board and are settled in shares of Class B Common Stock.
