conversion, we will deliver the conversion value to holders as follows: (1) an amount in cash (the principal return) equal to the lesser of (a) t
aggregate conversion value of the notes to be converted and (b) \$1,000, and (2) if the aggregate conversion value of the notes to be converted is
greater than the principal return, an amount in shares (the net shares) equal to such aggregate conversion value, less the principal return. The
number of net shares to be delivered will be determined as described in the prospectus.
