- On July 1, 2016, the reporting person elected to redeem 487 shares out of 610 shares of vested phantom stock previously granted under ARMOUR's Second Amended and Restated 2009 Stock Incentive Plan into 487 shares of ARMOUR's common stock. The reporting person also elected to redeem the remaining 123 shares of vested phantom stock, but immediately forfeited those shares to pay income taxes on the vesting grant. The 487 shares are part of, and relate to, phantom stock vesting over five-year periods, which was reported on a Form 3 filed by the reporting person on September 6, 2013.
