On April 11, 2005, Rentrak Corporation (the "Company") entered into a Separation Agreement and Mutual Release (the "Separation Agreement") with Craig Berardi, whose employment as Vice President - Product Services terminated on March 17, 2005. Under the Separation Agreement, unless Mr. Berardi revokes the agreement prior to April 15, 2005, he will be paid as severance a total of \$112,500 in 18 equal monthly installments. The Company will also pay the premiums for group health insurance coverage for Mr. Berardi and his dependents through December 31, 2005, if Mr. Berardi elects continuation coverage. The Separation Agreement includes mutual releases by each party of all claims against the other arising out of or in any way related to Mr. Berardi's employment with the Company.
