On March 10, 2005, Johnson Outdoors Inc. (the Company) issued to certain employees of the Company an e-mail reminder (the Reminder) regarding the special meeting of the Company's shareholders to be held March 22, 2005 to consider the Agreement and Plan of Merger providing for the merger of JO Acquisition Corp., a Wisconsin corporation, with and into the Company. Under the terms of the proposed merger, public shareholders of Johnson Outdoors would receive cash for their shares, and the members of the Johnson family would acquire 100% ownership of Johnson Outdoors.
