The name of the issuer is Provident Financial Holdings, Inc. the "Company").

("TFPO"), a company organized under the laws of the Cayman Islands, with respect to the shares of Common Stock directly owned by TFPO; and
- (v) Jeffrey L. Gendell, with respect to the shares of Common Stock directly owned by each of TP, TFP and TFPO.
