Common Units are redeemable for cash or, at the option of the Issuer, convertible into shares of the Issuer's common stock based on a conversion ratio described in the partnership agreement of Subsidiary, which, on May 12, 2015, was 0.93687068 shares of the Issuer's common stock for each Common Unit. The LTIP Units reported herein were issued as an annual award under the Issuer's 2011 Stock Incentive Plan.

- (3) Per LTIP Unit purchase price.
- (4) Includes LTIP Units previously granted to, and reported by, the Reporting Person having different grant dates, some of which have achieved parity with the Common Units.
