## Item 11. Temporary Suspension of Trading Under Registrant s Employee Benefit Plans.

The registrant has elected to change the record keeper for the infoUSA, Inc. 401(k) Plan (the Plan). As a result of this change, there will be a blackout period in which Plan participants temporarily will be unable to: (1) request a loan or a withdrawal, (2) change their investment elections for new deposits and/or change current investment holdings, or (3) change their current salary deferral percentage.
